TEAMS: Teams consists of 5 to 8 members. Top 5 runners will score. All teams must be in registered USATF-NJ clubs. Each club may enter more than one team. All individuals on a team must send their application with the team entry.

AWARDS: USATF medals to top ten individuals in each age group. Patches to 1st overall and team champions in each age group.

ADVANCEMENTS: Top 25 individuals and top 4 teams in each age group will advance to the Region II Championships hosted by the Niagara Association in the Syracuse area on November 22nd: <http://www.usatf-niagara.org/>. *All advancement paperwork for the Region II meet must be completed and paid for (cash or money order only) prior to leaving Stockton State College on November 2nd. The advancement form is on the NJ website. Bring a completed copy of it to this state meet to expedite the advancement process.*

REGISTRATION: All Individual and Team registrations must be received by Monday, Oct 27th. **NO POST-REGISTRATION!**

ENTRY REQUIREMENTS & FEES: 1) **Proof of Age:** copy of birth certificate, passport or age-verified USATF-NJ card; 2) **Entry Fee** of \$6.00; 3) **USATF-NJ Membership** number. USATF-NJ membership is required to compete in the Junior Olympic Program.

If you do not have a membership, obtain one online at www.usatf.org for \$19.95 (18 years and under). Print the online receipt & bring to the race as proof of membership. **MEMBERSHIPS WILL NOT BE SOLD AT THE MEET. BRING YOUR MEMBERSHIP # IN ORDER TO COMPETE.**

DIRECTIONS: *From Northern NJ:* Take Garden State Parkway South to exit 44; turn right onto Port Republic Road; go 1/2 mile. Turn left onto the main college road & follow to athletic field house. *From Atlantic City Expressway:* Take exit 12, turn left. Proceed straight past light at Route 30/ White Horse Pike. At next light turn right onto Jim Leeds Road. Go 1 mile & turn left onto the main college road. Follow to athletic field house.
